Two Divisions: Adult Division & Youth: all Youth winnings will be deposited into SMART

Rules of Tournament Play:

1. This tournament will be a 4-game singles no tap handicap event. No Tap: Automatic strike is given for knocking down 9 pins. Anything less than 9 you must pick up the spare.
2. Prize money portion of entry fee will be returned 100% within each division with 1 out of 4 entries cashing. Separate prize fund for Adults & Youth. **Youth prize winnings will be given in the form of SMART scholarship funds.**
3. Adult handicap ratio is 100% of 200. Youth handicap ratio is 100% of 200.
4. Break down of entry fee: Lineage -\$11.80; Expenses - \$2.20; Prize Fund - \$16.00
5. Averages are based on highest 2019-2020 yearbook averages.
6. If a bowler does not have a yearbook average, they can have a 2018 summer league average or must show proof of a current league average of 21 games. 12 for Youth.
7. Bowlers will bowl 4 games: total pins, plus handicap will determine winners. If there is a tie for first place, the 1st & 2nd place prize fund will be divided equally.
8. Any rules not covered by the above shall be governed by the USBC Rules and Bylaws.
